VISA HANDLED BY VFS

Entry of passengers who are subject to visa requirements and are traveling on an expired or invalidated passport containing a valid visa.

With immediate effect and until further notice, Switzerland tolerates persons subject to visa requirements to be transported, to enter and to stay in Switzerland if, upon entering Switzerland, they are traveling on:

- an officially recognized and valid passport (without visa) and on
- an expired or invalidated passport provided with a valid visa.

Refusal of entry for other reasons is expressly reserved.

Note: This regulation remains in force until further notice and is subject to the Schengen states agreeing on a more rigorous visa practice.

Note: All Schengen Countries, 20 Years passport will not be accepted.

Business Visa

- Valid passport (**Copy of the Passport - 2 copies of first page on a separate sheet, one copy of last page**)
- Visa form
- Two Recent Photographs 35mm x 45mm with white background & without border, 80% face should be seen (*Photographs should not be old for more than 6 months*)
- Overseas Medical Insurance
- Declaration along with all visa application and signature of the passenger on it
- Covering letter
- Invitation letter and Business correspondence
- Return ticket
- Income tax papers / salary slip for last 6 Months
- Bank Statement

Tourist Visa

- Valid passport (**Copy of the Passport - 2 copies of first page on a separate sheet, one copy of last page**)
- Visa form
- Two Recent Photographs 35mm x 45mm with white background & without border, 80% face should be seen (*Photographs should not be old for more than 6 months*)
- Overseas Medical Insurance
- Covering letter
- Foreign Exchange or International credit card
- Income tax papers 3Years/ salary slip for last 6 months
- Return ticket
- Hotel Confirmation
- Bank statement
- In recent marriage case the name of spouse should be mention on the passport or Original marriage certificate require with notary and home department from the issued place
